LEVERAGE YOUR DONATION THROUGH **CORPORATE MATCHING** GIFTS

Many companies will generously match gifts made by an employee to charitable non-profit organizations such as Legacy Magnet Academy's PTO! If you or your spouse work for, or have retired from, a company that offers corporate matching, you may be able to DOUBLE or even TRIPLE your cash gift to LMA's PTO.

Here's how it usually works:

1. Check with your company's human resources or payroll department to see whether it offers a matching gift program. You can also go to: <https://www.matchinggifts.com/rit/> to see if your company offers such a program.
2. Obtain a matching gift form from your company's human resources or payroll office.
3. Follow your company's procedure on submitting your funds, filling out the appropriate forms to ensure that the match is donated. Some companies might request a copy of a donation confirmation letter from the 501(c)3 organization. Please contact us by email at lmptoboard@gmail.com for this letter.
4. Please send an email to notify the PTO at lmptoboard@gmail.com after you have done this, including the amount of your contribution, so they know in advance to look out for it.
